Two Hundred Fifty to Rs. Five Thousand in each case for not providing of services without sufficient and reasonable cause under section 9 (1) of the Act and Rs. Two Hundred Fifty per day with a ceiling of Rs. Five Thousand for undue delay under section 9 (2) of the Act .

Provision for compensation up to Rs. One Thousand has also been made under section 9(3) of the Act . This amount would be paid to the appellant by the designated officer responsible for delivering the services .
 These orders should be implemented in letter and spirit.
